## Helping Vermonters with brain injury

#### **Program Summary**

The Brain Injury Program (BIP) provides rehabilitation and life skills services to help Vermonters with a moderate to severe traumatic brain injury to achieve their optimum independence and help them return to work.

#### Eligibility

To be eligible for Brain Injury Program the person must:

- Be a Vermont Resident 16 years of age or older
- Be eligible for traditional and/or long-term Vermont Medicaid
- Be diagnosed with a moderate to severe brain injury within the last five (5) years prior to date of application
- Demonstrate a potential to benefit from rehabilitation
- Demonstrate a potential for independent living and returning to vocational activities

#### Services

Services are provided as part of a comprehensive person-centered plan of care, which is developed through collaboration to meet the needs of the individual. Types of services may include:

- Case Management
- Direct Support Person/Life Skills Aid
- Shared Living
- Crisis Support
- > Respite
- Employment Supports
- Environmental and Assistive Technology

#### **BIP Program Note**

- Room and board are not covered through the Brain Injury Program waiver. The provider agency and the prospective client are responsible for coordinating this item.
- Individuals requiring continued intensive one-to-one community supports may qualify for ongoing long-term services.
